- The interpretation and facilitation of communication, in language, oral and / or written and her / his assistance in all procedures where his presence is necessary for the communication of the staff with the beneficiaries of the program.
- Commitment to the principles of confidentiality, to act as a familiar person in the reception phase and the integration process and as a conduit for the assessment of information and actions for adult and minor beneficiaries to be accurate and properly evaluated.
